SECTION 4: FIRST AID MEASURES

4.1 <u>DESCRIPTION OF FIRST-AID MEASURES:</u>

SECTION 5: FIRE-FIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:

Extinguishing powder or CO2. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

SECTION 7: HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Comply with the existing legislation on health and safety at work.

General recommendations:

Use in areas free from sources of ignition and away from heat or electrical sources. Do not smoke. Handle with care, avoiding any discharge. Avoid any type of leakage or escape. Keep the container tightly closed.

Recommendations for the prevention of fire and explosion risks:

Vapours are heavier than air, may spread along floors to a considerable distance, can form explosive mixtures with air and are able to reach distant ignition sources and flame up or explode. Due to its flammability, this material should only be used in areas from which all naked lights and other sources of ignition have been excluded and away from other heat or electrical sources. Switch mobile phones off and do not smoke. No tools with a potential for sparks should be used.

8.2 **EXPOSURE CONTROLS:**

ENGINEERING MEASURES:









Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction.

Avoid the inhalation of vapours. Protection of respiratory system:

Protection of eyes and face: Install water taps, sources or eyewash bottles with clean water close to the working area.

Protection of hands and skin: Install water taps or sources with clean water close to the working area. Barrier creams may help to protect the exposed areas of the skin. Barrier creams should not be applied once exposure has occurred.

OCCUPATIONAL EXPOSURE CONTROLS: Regulation (EU) No. 2016/425:

As a general measure on prevention and safety in the work place, we recommend the use of a basic personal protection equipment (PPE), with the corresponding marking. <u> Mask:</u>

A-type filter mask (brown) for gases and vapours of organic compounds with a boiling point higher than 65°C (EN14387). Neoprene rubber gloves (EN374). The breakthrough time of the selected glove material should be in accordance with the pretended period of use. When repeated or prolonged contact with the product is expected, gloves of protection level 5 or higher should be used, with a breakthrough time of >240 min. When short contact with the product is expected, use gloves with a protection level 2 or higher should be used, with a breakthrough time > 30 min.There are several factors (for example, temperature), they do in practice the period of use of a protective gloves resistant against chemicals is clearly lower than the established standard EN374. Due to the wide variety of circumstances and possibilities, the instructions/specifications provided by the glove supplier should be taken into account. Use the proper technique of removing gloves (without touching glove's outer surface) to avoid contact of the product with the skin.
